*Answer: Attached for February and January 2021. \*These invoices are reflective of hybrid school, with some days of no in-person school schedules.*

## **Q&A Round Two (2):**

**Section A 2. Bullet #5-After school late bus includes 2 buses and maybe 2 days a week for FY22. Can you please explain the requirement or scope of the late buses? For example, times, locations, and number of stops?**

- **I see in the invoices it appears the 2 late buses were run on Wednesday's only but with a full rate of \$432.30.**

*Answer: We typically run two (2) buses, at least one (1) day per week at the Middle School. In FY20, it was Tuesdays. Both buses picked up after school students and stopped at a handful of stops around the Town. We may request this to be the case for two (2) buses, two (2) days per week if there is after school programming needed due to COVID-19. The rate is the current fiscal year's rate, per day, not per bus; i.e., we have two (2) buses, one way for drop-off and only pay the daily rate for one bus (essentially each bus is the half price of one full day's rate). The*

*Wednesday's are the remote learning days, where we were (prior to April 5<sup>th</sup>) transporting only vocational students, and needed two additional buses around Town to pick those (approximately) seventy-five (75) students up to get them to the central location of the vocational buses.*

**Is a bid bond acceptable versus submitting a certified check for our proposal?**

*Answer: Yes, either a bid bond or a certified check is acceptable.*
