1. Call to Order

2. Showcase

Jeffrey Berthiaume and Maggie Lavelle discussed the new LCAC relationship the School Department has developed with the LCAC and the creation of the new Digital Publishing Course at the high school. The LCAC board members gave the school department \$6,000 to start the program. These funds were used to purchase new equipment [Ipads and kits] to assist with new technology, video recording and editing. Jeff and Maggie would like to see this course expand into LMS as well.

Maggie Lavelle discussed her new Digital publishing Course, which is a half-year course. She gave a brief overview of what is being done in the classroom. The faculty and staff from the Digital Publishing Course have video on demand on the district website under LPS TV. There are several categories to choose from such as Bees Knees, Game Plan, Club Corner, Tony Talk Show, and What is Going on in LTown just to name a few.

5.1 Student Liaisons report

The new Student Liaisons Brenda Nguyen and Hannah Gallant reported on recent and/or upcoming events happening in all the schools for the month of October.

5.2 School Committee Chairperson Report

School Committee Chair, Stella Richard discussed the School Committee roles and responsibilities. The responsibilities of the school committee fall under strict guidelines set by the state. Their main focus is reviewing, writing and revising the school policies that govern LPS and to run their meetings following open meeting law guidelines in both public and executive sessions, ask questions about the budget and other matters that come up, also, we hire and evaluate the Superintendent. In addition, we inform the public about matters from our meeting, provide updates on the PreK-8 school Building project committee and our upcoming vote this May at the Town meeting. Some of the members on the committee are parents of children currently in our schools. We are always happy to answer questions from people we see at events but it is not in our purview to handle matters between students and their teachers or administrators, or employee matters that may come up. If there are issues, matters or questions at any of the schools there is a chain of command that goes all the way up to the Superintendent's role. I hope I helped to clarify the roles as a school committee member to everyone in case there was any confusion.

5.3 Superintendent's Report

a. MSBA Update

The Superintendent did not feel there was a need for an MSBA update after all the information and presentation Paul McCarthy provided on the school building project

b. Comprehensive District Review

The Superintendent informed the Committee members that DESE has provided a date for the Comprehensive District Review. The Department of Elementary and Secondary Education will be on site the week of February 3 - 6, 2020. The district must upload its self-assessment by January 10, 2020. After the self-assessment has been reviewed, DESE will let the district know what files they will be reviewing as well as what groups they would like to meet with.

The Superintendent will disseminate the information to the Committee members as it is received from DESE regarding the district review.

5.4 School Committee Liaisons Report

School Committee Member, Scott Francis provided an update on the Student Opportunity Act. That the Massachusetts Senate on Thursday, October 3, 2019, passed a major overhaul of the education funding formula, which would require the state to spend another \$1.5 billion annually on public education by the time it is fully implemented. The main focus of the bill is to assist districts with a large number of low income students and ELL with more funding.

The bill moves to the Senate Ways and Means Committee on 10/16/2019.

Every three years, school containing asbestos materials must be reinspected to determine if any known or suspected asbestos-containing buildings materials have changed and recommendations are made on the managing abatement.

Hub Testing Laboratory, Inc. went through all the buildings, updated all paperwork and identified that Leicester Public Schools is in total compliance. Hub will continue to monitor and survey the condition of these materials every six months to assure that they remain in good condition.
