Having convened in an open meeting on February 11, 2020, prior to the SOI submission closed date, the School Committee of Leicester, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent to submit to the Massachusetts School building authority the State of Interest Form dated February 13, 2020 for the Leicester High School located at 174 Paxton Street, Leicester, MA 01524 which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future; replacement of two Burnham 3099 MBH oil fired cast iron boilers, installed at the time of the construction of the school in 1995, and hereby further specifically acknowledges that by submitting this Statement of Interest form, the Massachusetts School Building Authority in no way guarantees the acceptance or the approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority, or commits the Town to filing an application for funding with the Massachusetts School Building Authority.
