Policies

• Review- JQ- Student Fees, Fines, and Charges

The Committee, along with Jeff Berthiaume discussed the DESE findings on the LPS Policy regarding charging a fee for use of the district owned Chromebook. DESE states the district cannot charge a fee for use of materials used to access the daily curriculum. Mr. Berthiaume says we do not charge for the use of the Chromebooks but do ask families to pay for insurance on the device. The discussion was tabled until more information can be gathered.

• Policies D review

The LPS Section D policies were moved to a second reading at the next School Committee meeting.

Principal Reports

Dr. Tencza asked the building principals to give an update on how this school year is going.

The building Principals report that systems and protocols are in place for everyone's health and safety, staff and students adjusted well to new systems and routines, and small class sizes are offering more individual attention to students.

Areas of concern are student have limited personal interactions with peers, staff is overwhelmed with planning for synchronous, asynchronous, and in-person learning, and tracking attendance for asynchronous students is difficult.

The pressure put on families during synchronous and asynchronous days; the level of support needed for the Elementary and early Middle School students is great.

The Principals stated the lack of substitute teachers has been a problem. Administrators, paraprofessionals and other support staff have been key in covering staff absences.

Mrs. Boss, Principal of the Elementary School, thanked the staff and families for their hard work and perseverance.

Mr. Fontaine, Principal of the Middle School thanked staff for their flexibility due to the lack of substitute teachers.

Ms. Tracey Kenney stated the NFS, the cleaning crew, is doing a good job keeping the building through the day.

State Guidelines for In-person School Committee meetings

The Committee discussed the possibility to have in person meetings. The Governor released new guidelines regarding limit of 10 people for indoor gatherings. The Committee asked for more information.

Flu Vaccination Requirements

Governor Baker ordered all public school students (in-person and hybrid) receive a Flu Shot before December 1, 2020. Diane Moffat and Melissa Ledbetter are waiting for guidance from DESE.

Travel Requirements for Students/Staff who Travel during Holidays

A notice was sent to all families and staff regarding travel during the upcoming holidays. If traveling outside the state, student/staff will need to quarantine or be tested before returning to school. DESE is not recommending a school closure after Thanksgiving.

COVID Update (School & Town)

Currently there have been 3 cases of COVID in the schools. There has not been any in school transmission of the virus. The committee asked would define a "cluster" that might cause a school closure. Diane Moffat said it would depend on how the virus is being transmitted. Melissa Ledbetter stated that if 3% of the school were to become positive in short amount of time, this could be considered a cluster.

Remote Learning Update

Dr. Tencza stated that 4 facilitators have been hired for Cohort D. Dr. Joseph is currently meeting and training the facilitators. The facilitators will begin working with the students next week.

Central office staff have printed FVLS lessons for families that have requested them.
